Spring 2018 Request for Proposals (RFP) - *Community Health Grant Program*

**Granting Priorities**

Reflecting its purpose of promoting the health and well-being of the residents of Trumbull County, the Trumbull Memorial Health Foundation requests proposals for innovative projects that address the **current priorities identified by the Trumbull County Combined Health District Community Health Assessment.**

**Trumbull County Combined Health District Community Health Assessment Priorities:**

- 1. Reduce prevalence of chronic disease**  
*Initiatives that increase physical activity, improve healthy eating, and reduce tobacco use*
- 2. Limit injury and violence**  
*Initiatives that reduce drug abuse and improve maternal/child safety*
- 3. Reduce infant mortality**  
*Initiatives that reduce prematurity and low birthweight and reduce sleep related deaths*
- 4. Integrate physical and behavioral health**  
*Initiatives that improve the integration of physical and mental/behavioral health*

In addition, the Trumbull Memorial Health Foundation gives priority to projects that:

- Address underlying social and economic challenges contributing to poor health outcomes in the communities served, such as poverty, lack of access to healthy foods and absence of parks/recreational centers
- Extend past individual behavior or *program* related services by modifying policies, systems and environments to help make healthy options practical and readily available
- Demonstrate collaboration among sectors, including public health, government, education, healthcare, etc.
- Prioritize engagement of residents from the communities served
- Adhere to existing evidence-based best practices or promising practices
- Leverage additional funding as well as community assets
- Provide an established plan for evaluation including measurable outcomes

**Guidelines**

Eligible applicants must be tax-exempt organizations under Internal Revenue Service 501(c)(3) or operate under the fiscal sponsorship of a tax-exempt non-profit, including schools, churches and public organizations. Eligible organizations must provide services which contribute to the health and wellness of the residents of Trumbull County.

**How to Apply**

Interested applicants must submit a **letter of inquiry form (LOI)** on or before **February 16, 2018 at 4:00 p.m.** Please do not submit a full proposal unless invited to do so. If the LOI is accepted, an application form will be made available. Those invited to submit a full proposal will be notified in late March 2018. Completed applications with supporting documents must be submitted to the Trumbull Memorial Health Foundation on or before April 27, 2018 at 4:00 p.m. Final grant decisions will be announced in June 2018.
